# **COOKIES POLICY**

GOSUPPLY ADVANCED APPLICATIONS, S.L. aims to respect the privacy of its users and protect the personal data that they may provide to GOSUPPLY ADVANCED APPLICATIONS, S.L. and/or that cookies may obtain.

In this document you will find all the information about the cookies we use. As a sign of commitment to data protection regulations, GOSUPPLY ADVANCED APPLICATIONS, S.L. permanently makes available to the user the information regarding our cookie policy.

## What are cookies?

A cookie is a small file that is stored on the user's device with information about navigation.

The user is informed that this website uses cookies and / or similar technologies that store and retrieve information when browsing. In general, these technologies can serve very different purposes, such as, for example, recognizing you as a user, obtaining information about your browsing habits, customizing the way content is displayed, the user's browsing language, the country, the login, browser characteristics, or even information about the date and time of the last visit, traffic parameters within the website and the number of visits.

The specific uses we make of these technologies are described in the table of cookies contained in this policy.

#### What types of cookies exist?

### According to its purpose:

- **Techniques:** These are those necessary for navigation and the proper functioning of the website. They allow, for example, to control traffic and data communication, access parts of restricted access, carry out the process of purchasing an order, use security elements, etc. These cookies do not require the user's consent for its installation, as established in the Cookie Guide of the Spanish Data Protection Agency and current regulations.

- **Personalization:** These are those that allow access to the service with predefined characteristics based on a series of criteria, such as the language, the type of browser through which the service is accessed, the regional configuration from where the service is accessed, etc. These cookies do not require the user's consent for its installation, as established in the Cookie Guide of the Spanish Data Protection Agency and current regulations.

- Analysis: These are those that allow quantifying the number of users to perform the statistical measurement and analysis of the use made by users of the service offered. For this, the user's navigation on the website is analyzed in order to improve the offer of products or services offered.

- **Behavioral advertising**: these are those that store information on user behavior obtained through continuous observation of their browsing habits, which allows the development of a specific profile to display advertising based on it.

- Advertising: These cookies allow the management of the advertising spaces included in this website, such as, for example, the frequency with which the advertisements are displayed.

#### According to the period of time in which they remain active:

- Session cookies: These are temporary cookies that remain in the browser's cookie file until the web page is left, so none is recorded in the device's memory. The information obtained through these cookies is used to analyze traffic patterns on the web. In the long run, it provides a better experience to improve the content and facilitate its use. You can identify the session cookies in the table contained in this policy, under the heading "At the end of the browsing session."

- Persistent cookies: They are stored on the device and the website reads them each time a new visit is made. A permanent cookie has a specific expiration date, which may vary depending on the functionality for which it has been assigned. The cookie will stop working after that date. You can see the information regarding the duration of persistent cookies in the table set out in this policy.

### According to who manages them:

- Own cookies: These are cookies that are stored on the user's device by our computers or domains and from which the appropriate service of the website is provided.

- Third-party cookies: These are cookies that are stored on the user's devices and that are not managed by GoSupply, but by a third-party collaborator. By way of example, are those cookies used by social networks, video views or by the information provided by Google Maps to locate us. Please note that if you accept third-party cookies, you must delete them from the browser options or from the system offered by the third party itself.

## Who uses the information stored in Cookies?

GoSupply uses the information stored in the cookies of this website exclusively for us, except for those cookies identified below as managed by "Third Parties", which are used and managed by external entities to provide us with services requested by us, in order to help us to improve our services, as well as the user experience when using our website. In the following section, the type of cookies used by third parties are specified.

## How long do we keep the information collected with cookies?

Personal data will be kept until the authorizations granted by the user remain in force or until the cookie's functionality time expires, in accordance with the data protection regulations and Law 34/2002, of July 11, of services of the information society and electronic commerce. You can check the table that details the cookies used on this website to learn more about the storage of collected information.

# What is the legal basis for managing cookies?

The legal basis for the processing is consent, which can be managed and / or revoked according to the indications contained in this document.

# Do we transfer cookies to third countries?

In general, the cookies used are not transferred to countries located outside the European Economic Area. In some cases, data transfers may be carried out by service providers located outside the European Economic Area, but respecting the appropriate guarantees, as established in article 46.2 of the General Data Protection Regulation of the European Union (GDPR) and always keeping the security of your data, providing a level of protection comparable to that of the European Union.

### How to deactivate cookies?

When accessing the website, the user will see a cookie notice in which they will be informed of the way in which they can consent or reject the installation of them.

Likewise, the user, at any time, may disable or delete the cookies used on this website through the browser settings used on their device. Below, we provide you with information on how to activate and deactivate cookies in the main web browsers:

To inform that it is possible that the cookie management system provided for accepting, rejecting or configuring cookies may not allow the use of third-party cookies. In this regard, if third-party cookies are accepted and later need to be deleted, it must be done through the browser itself, following the specifications detailed in the links provided in this section.

# Data subject's Rights

Users have the following rights regarding data protection:

	Data subjects have the right to request GO SUPPLY to rectify inaccurate information that concerns them.
RIGHT	They also have the right to complete incomplete personal information, which can be made through an

RIGHT TO ERASURE / RIGHT TO BE	Data subjects have the right to erasure, once exercised, GO SUPPLY have to delete personal data that

### Minors
